Arts Education: VSA Vermont offers inclusive education classes and workshops in visual arts, music, theater and dance to Vermonters of all ages and abilities in every county of Vermont. VSAVT arts education programs are designed to offer participants opportunities to develop their strongest creative voices for fuller participation in community life. All our education programs are collaborative and help partnering organizations to achieve their goals.

Professional Development: VSA Vermont offers professional development workshops for artists who learn inclusive teaching methods, and for educators and social service providers who learn to use the arts as a way to more fully engage their students or those receiving services. An additional component of VSAVT's professional development program is assistance to artists with disabilities in furthering career goals in the arts. VSAVT's professional development programs directly serve 460 adults annually.

Public Awareness and Cultural Access: VSA Vermont presents art exhibitions and original theater in live shows, VSA-produced public access television and film. VSA Vermont also partners with venues such as the Flynn Center for the Performing Arts and the Shelburne Museum to assist in increasing the number of artists with disabilities presented at those venues and the number of audience members with disabilities welcomed and accommodated. VSA directly serves 500 adults and children annually and reaches a potential audience through television and other media of 300,000.
