Arts Education: In collaboration with partnering educational and social service organizations, VSA VT provides inclusive arts education workshops in visual arts, music, theater, and dance for Vermonters of all ages and abilities. Our education programs are designed to help participants use their strongest expressive means for engaged community participation. 600 people were served at sites representing all counties of Vermont. Education experiences have a minimum of 8 hours and some have a longer period.

Professional Development: VSA Vermont professional development workshops and classes are designed to help artists learn inclusive teaching methods, and to help educators and social service providers use the arts to more fully engage their students or clients. VSA VT professional development programs are presented in collaboration with a variety of arts and education partners. 125 people including early childhood educators, museum educators, teaching artists and classroom teachers, representing every county in Vermont, were served. Early childhood educators receive 20 training hours authorized by the State of Vermont for advancement in professional development and quality rating systems.
