Arts Education: In collaboration with partnering educational and social service organizations, VSA VT provides inclusive arts education workshops in visual arts, music, theater, and dance for Vermonters of all ages and abilities. Our education programs are designed to help participants use their strongest expressive means for engaged community participation. 650 people were served at sites representing all counties of Vermont. Education experiences have a minimum of 8 hours and some have a longer period.

4b (Code:) (Expenses \$ 55,255. including grants of \$) (Revenue \$ 44,370.)

Professional Development: VSA Vermont professional development workshops and classes are designed to help artists learn inclusive teaching methods, and to help educators and social service providers use the arts to more fully engage their students or clients. VSA VT professional development programs are presented in collaboration with a variety of arts and education partners. 135 people including early childhood educators, museum educators, teaching artists and classroom teachers, representing every county in Vermont, were served. Early childhood educators receive 20 training hours authorized by the State of Vermont for advancement in professional development and quality rating systems.

Cultural Access: VSA Vermont assists art organizations in presenting more artists with disabilities and in welcoming more visitors and audience members with disabilities. We also engage the public in inclusive arts activities such as events including our free BOOM VT drum festival, which expanded from a one-day event to a program tht involves workshops and public awareness events throughout the year. VSA VT cultural access programs are presented in collaboration with community cultural organizations and businesses across Vermont. The artwork of participants in VSAVT programs is presented in settings such as nursing homes, restaurants, public libraries, and local businesses. 155 people attended VSAVT brief workshops at social service agencies, libraries, and arts venues to learn skills and raise awareness of inclusive arts practices.
